Provisions

1. The license for WRHC is held by **Harbor Arts**, a 501(c) 3 non-profit organization.
2. Underwriting Agreement & payment must be in place by the 20th of the month in order to begin at the beginning of the following month.
3. WRHC is licensed by the FCC as a non-commercial LPFM broadcaster, and as such will comply with all FCC regulations appropriate to such licensing.
4. Underwriters of WRHC do not have authority to exercise any control over the programming or policies of WRHC, shared programs of WRHC, live remote broadcasting or any other content.
5. WRHC reserves the right to decline underwriting to businesses, organizations, and individuals for any reason.
6. WRHC reserves the right to edit underwriting text to insure compliance with FCC regulations.
7. Programs may have more than one underwriter. WRHC will make every effort to insure against businesses of the same type underwriting the same broadcast hour.
8. Underwriting fees are due at the signing of this agreement. If fees are not received before the renewal date, it will result in cancellation of this agreement and on-air mentions associated with same.
